

SRES® Designation Application

For prompt processing of your application:

- > Submit your application only after you have met all of the requirements.
- > All of the fields in the application must be filled out. Incomplete applications may delay processing.

After submitting your application:

- > Please allow your provider up to 2 weeks to submit your application to the SRES® Council.
- > As a reminder, please do not market yourself as an SRES® designee until the Council has conferred the designation and you have been notified.

When your application is approved:

- > When SRES® approves your application, we will notify you by e-mail, after which you may add SRES® to your credentials and marketing materials.
- > Your SRES® pin, letter, and Certificate will be sent to your preferred mailing address in the National REALTOR® Database System (NRDS) (International members will receive packet to the address provided on the application).

Active membership with SRES® Council is required:

- > In order to retain the rights to use the SRES® designation, you must maintain your membership with the Seniors Real Estate Specialist® Council as well as with NAR or an NAR cooperating international association.
- > Using the SRES® designation without maintaining membership with the Seniors Real Estate Specialist® Council will result in a trademark violation (Code of Ethics, Article 12). Those individuals in trademark violation will need to immediately cease from using the SRES® trademark/logos on all promotional materials.
